- 3) the contracting, hiring, purchasing, disbursing and other pertinent policies shall be observed.
- 4) claims paid will be approved at its next regularly scheduled public meeting.
- 5) if any claims are disapproved, the auditing officer and the officer(s) designated to sign the checks or warrants recognize these claims as receivables of the Authority and will pursue collection diligently until the amounts are either collected or the Board of Directors is satisfied and approves the claims.
