A RESOLUTION AUTHORIZING THE MASON TRANSIT AUTHORITY BOARD CHAIR TO SIGN WASHINGTON STATE DEPARTMENT OF TRANSPORTATION AGREEMENT #GCB1624

WHEREAS, Federal funding is authorized under the Moving Ahead for Progress in the 21st Century Act (MAP-21), Enacted as Public Law 112-141, July 6, 2012; or other Federal laws the Federal Transit Administration (FTA) administers to the extent FTA so determines;

WHEREAS, the State of Washington in its Sessions Laws of 2013, chapter 306, section 220 provides Rural Mobility, Paratransit/Special Needs, and other special proviso funding through the multi-modal transportation account and rural mobility grant program account, as identified in the budget through its 2013-2015 biennial appropriations to Washington State Department of Transportation (WSDOT);

WHEREAS, funding is authorized under 49 USC § 5311 / MAP-21 for Rural Areas Program; and any subsequent amendments and resolutions thereto;

WHEREAS, funding is authorized under 49 USC § 5311 /SAFETEA-LU Nonurbanized Area Formula Program; and any subsequent amendments and resolutions thereto;

WHEREAS, WSDOT's Public Transportation Division administers the State Tax Equalization Revenue Transit Formula Grant Program to provide assistance to transit agencies for transportation related support of persons in non-urbanized and small urban areas;

WHEREAS, WSDOT's Public Transportation Division administers the Paratransit/Special Needs Transit Formula Grant Program funds to provide assistance to transit agencies for transportation related support of persons with special needs;

NOW, THEREFORE, BE IT RESOLVED, that the Mason Transit Authority enter into mutual Agreement #GCB1624 with the Washington State Department of Transportation for a total of \$5,117,961 in operating funds which includes \$2,229,565 in Contractor Funds to sustain transportation services.

BE IT FURTHER RESOLVED that the Mason Transit Authority Board hereby authorizes the Chair to execute said Agreement #GCB1624 as Contractor on behalf of Mason Transit Authority.
