## **RESOLUTION NO. 2017-34**

A RESOLUTION OF THE MASON TRANSIT AUTHORITY BOARD AUTHORIZING THE GENERAL MANAGER TO SIGN A CONTRACT WITH NELSON/NYGAARD OF SEATTLE, WASHINGTON, TO PROVIDE SERVICE REVIEW CONSULTATION SERVICES IN AN AMOUNT NOT TO EXCEED \$150,000.

**WHEREAS**, the Mason Transit Authority ("MTA") Board by motion at its June 20, 2017 meeting, authorized the General Manager to proceed with the request for proposal process of seeking a consulting firm to conduct an overall review of MTA's current services and route structure; and

**WHEREAS,** on September 21, 28 and October 5, 2017, a request for bids was published by the Daily Journal of Commerce, and also posted under the Bids & Contracting Opportunities tab on the Washington State Office of Minority & Women's Business Enterprises website requesting that bids be submitted to Mason Transit Authority no later than 2:00 p.m. on Friday, October 20, 2017, to MTA's Administration Office located at 790 E. Johns Prairie Rd, Shelton, WA 98584; and

WHEREAS, two bids were timely submitted; and

**WHEREAS,** after interviews by a panel consisting of two MTA Managers, two MTA Board members and a member of MCTAB, and the scorecards submitted by the members of the panel, Nelson/Nygaard was the winning bidder and found to meet all the necessary specifications and requirements and at a lower cost.

NOW THEREFORE, BE IT RESOLVED BY THE MASON TRANSIT AUTHORITY

**BOARD** that it awards the bid submitted by Nelson/Nygaard of Seattle, Washington, as the winning bid in an amount not to exceed \$150,000, and will serve as the Service Review Consulting firm to conduct the overall review of MTA's current services and route structure; and hereby authorizes the General Manager to sign the contract between Nelson/Nygaard and Mason Transit Authority.
