NOW THEREFORE, BE IT RESOLVED BY THE MASON TRANSIT AUTHORITY BOARD to approve Capital Grant Agreement No. PTD0690 of the Consolidated Grant Program for the purpose of purchasing three (3) replacement heavy duty buses; and

BE IT FURTHER RESOLVED that the General Manager is authorized to execute Agreement PTD0690.
